People's Parliament Relationship ideas

The next People's Parliament is going to be about relationships.

The topic relationships has been chosen because of how big an impact relationships can have on people's life. Relationships can be a husband and/or wife, friendship, family members, neighbours or professional.

The group are asking for ideas of what could be discussed at the next People's Parliament.

Martin said a good discussion would be to map circles of support, not just support workers but the wider circle.

Another idea would be to have the "bank account" discussion. This is where people would list those people

making payments into the account i.e. making you feel good, helping you, being kind and supportive. Then identify those people who are making debits on the bank account, i.e. who are the people not making you feel good or helping you.

Gail said one area to look at will be how do you manage conflict and restore relationships if there has been a fall out.

The group said a big area to look at is how do you manage social media relationships?

Worcestershire County Council Budget

Fran told the Board about the budget problems that the Council are having.

Fran went through a presentation that she had prepared and Aimee will circulate this round to the Board.

Martin asked about the Home to School transport - is that the taxi owners effectively passing on increased costs or are they exploiting the fact that we have no choice but to use private companies?

Fran said it is a bit of both, Fran said the cost of fuel and other inflationary costs are a problem, but we do know that it is a private market and they are making profits and we sometimes have no choice but to use that market.

WCC are looking at whether they can get more control over the private market. WCC do have their own fleet, and

the team are looking at increasing the in-house provision as it might be better value for money.

Fran said at the next meeting she will bring a further update to the group.

Having a Place to Live Sub-Group

Sam told the Board that he has been out on visits and spoke to residents to find out what they like and don't like about living where they do. Some people said they would prefer to have better support than they have currently got. Overall, most people were happy with where they live. There were some people who were unhappy with their move.



Any Other Business

Fran shared the agenda with the Board for the first Herefordshire and Worcestershire joint LD Partnership Board. This is due to take place on 6th February and all are welcome.

Fran and Barbara updated the Board about the event that will be taking place in LD Week at Trinity Church. Barbara and Fran have met Nick who is the Chaplain at Trinity Methodist Church in Kidderminster, he was really helpful and keen to get involved. Nick is very supportive of it being an ecumenical service so that it is a community space to come together and raise the profile of LD in the community.

The event will be held on the last Sunday in June, 30th in the afternoon.

We are going to raise the profile of the Strategy and get some publicity, hopefully Worcester News. Barbara to confirm the 30th June date with Nick. A Task and Finish Group will be set up for the Event.

Barbara told the group about a surgery in Kidderminster, Aylmer Lodge, who are holding a clinic for people with LD who use that practice every Friday until March.

Martin said that going back through previous minutes, there is always a long list of people who couldn't attend. and was just wondering whether anything should be done to refresh the list of attendees. Aimee and Fran said that the list is regularly reviewed, but they will do another check that it is up to date.


