SEND Preparing for Adulthood

Fran went through the Highlight Report and explained that the group meets 3 times a year.

The group now have a new Carer Rep on the Group who has young adult children and have been through the SEND journey. This is a great addition to the SEND Preparing for Adulthood Group.

Jill said the Toolkit has been ongoing for a year and was coproduced. The Webinar has now been complete and will be rolled out to all schools. Morag said that Healthwatch have contacted Speakeasy to ask if they could promote the survey that they are doing for parents who will be involved in Education, Health and Care Plans.

Fran said the 14-25 Needs Assessment has some cross over with the work Healthwatch is doing and the Council will be working closely with them to progress this work.
