## **Description of the map**

The map shows the Prohibition of Waiting zone on Austin Road, Bromsgrove:

#### Austin Road - Bromsgrove - East Side

From a point 27m north of its junction with Miller Close for a distance of 12m in a northerly direction.

#### Austin Road - Bromsgrove - West Side

From a point 12m north of its junction with Miller Close for a distance of 40m in a northerly direction.
