Map and plan of the area

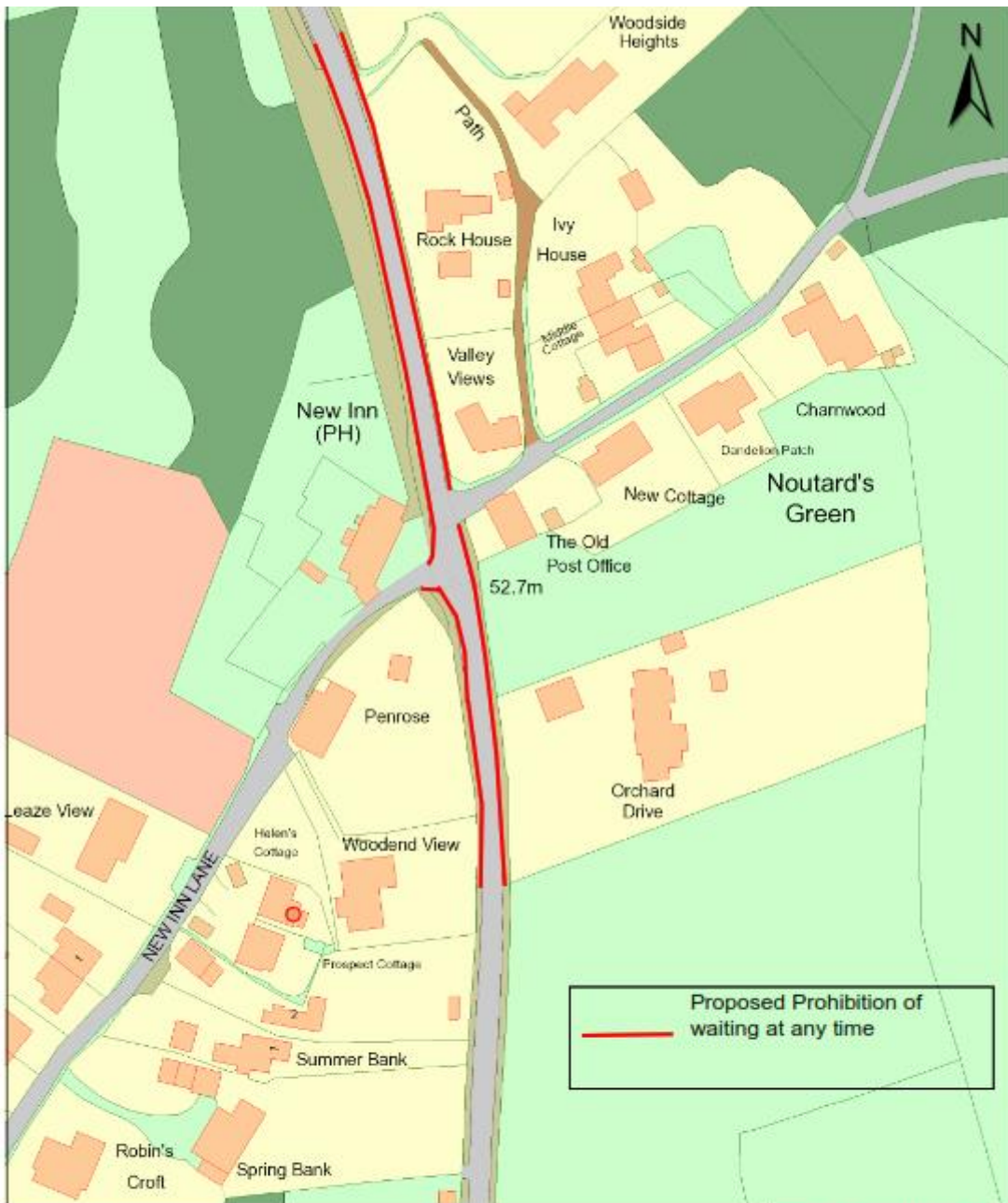
Map of B4196 Shrawley and the Prohibition of Waiting zone implemented by the above order.

Description of the map

The map shows the Prohibition of Waiting zone on B4196 **Shrawley**:-

B4196 Shrawley- (west side) from its junction with New Inn Lane for a distance of 116m in a northerly direction and 68m in a southerly direction.

B4196 Shrawley- (east side) from its junction with the lane to Noutards Green for a distance of 111m in a northerly direction and 85m in a southerly direction.
