Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (BOROUGH OF REDDITCH) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2009 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON STONEPIT LANE/ CHESTERTON CLOSE JUNCTION, REDDITCH]

Worcestershire County Council have made this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

Description of the map

The map shows the Prohibition of Waiting zone on Stonepit Lane, Chesterton Close Junction, **Redditch**:
Stonepit Lane (West Side) from a point 12 metres southwest of its junction with Brookfield close for a distance of 45 metres in a south westerly direction.
