- 1. The County of Hereford and Worcester (B4202 Clows Top Road and C2071 Village Road, Abberley) (40 M.P.H. Speed Limit) (No.5) Order 1995 is hereby revoked in its entirety.
- 2. The Worcestershire County Council (Various Roads, Abberley) (Restricted Roads and 40 Mph Speed Limit) Order 2000 is hereby revoked in its entirety.
- 3. No person shall drive or cause to permit to be driven any vehicle along those lengths of roads specified in Schedule 1 attached to this order at a speed exceeding 30 miles per hour.
- 4. No person shall drive or cause or permit to be driven any vehicle along those lengths of roads specified in Schedule 2 attached to this order at a speed exceeding 40 miles per hour.
- 5. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
- 6. This Order may be cited as Worcestershire County Council (Various Roads, Abberley) (30 M.P.H. and 40 M.P.H. Speed Limit) (Revocation and Proposal) Order 2025 and shall come into operation on 23 January 2025.

Map of Various Roads, Abberley and the update to the Speed Limit to be implemented by the above order.


Description of the map

The map shows the update to the Speed Limit on Various Roads, **Abberley: - Abberley** to **40 miles per hour:**

A443 (Stockton Road/Stourport Road): From a point 375 metres west of its junction with C2230 (Common Road) in an easterly direction then a south easterly direction to a point 100 metres southeast of that junction.

B4202: From a point 90 metres north of its junction with C2071 (Village Road) in a southerly direction to a point 215 metres north of its junction with A443 (Stockton Road/Stourport Road).

A443 (Stockton Road/Stourport Road): From a point 100 metres southeast of its junction with C2230 (Common Road) in a generally south easterly direction to a point 150 metres north of its junction with B4203.


