Decision Taken By:	Phil Rook, Chief Financial Officer			
Cabinet Member	Councillor Simon Geraghty, Leader of the Council with Responsibility for Finance			
Decision Made*	To record 2025/26 annual increase of fees charged for Worcestershire County Council (the Council) providing an Appointee Service based on the Retail Price Index (RPI) which is the recommendation contained within the Council's Income and Debt Policy and in line with best practice.			
	The fees have also been benchmarked with other local authorities and private sector firms offering the service and are deemed to be comparable			
	The fees levied relating to the Deferred Payment Agreement have not been reviewed or increased for several years. The revised fees have been calculated based on the average time taken to undertake an agreement and the staff cost associated with the service. This is in line with best practice and our Income and Debt Policy and are comparable with other service providers. The fees will be inflated by RPI in the future.

This would result in the service becoming no longer viable. No additional surplus will be receivable by the Council as the increase in fees fully offset the increase in staff costs following the pay award uplift for the staff undertaking the service.
