Description of the map

The map shows the proposed prohibition of waiting zone on Lansdowne Road & Lansdowne Crescent, **Worcester:** -

Lansdowne Road (South side): from its junction with Lansdowne Crescent for a distance of 8 metres in a westerly direction and 68 metres in an easterly direction. **Lansdowne Crescent (West side):** from its junction with Lansdowne Road for a distance of 11 metres in a southerly direction;

(East side): from its junction with Lansdowne Road for a distance of 5.5 metres in a southerly direction.
