# Early Years Bulletin: Worcestershire News and Reminders

#### **Nursery Education Funding**

#### Summer Term 2025

The Summer Term, from a funding perspective, starts on Tuesday 1<sup>st</sup> April. Children who are eligible for funding in the Summer Term, can access funding from 1<sup>st</sup> April, as part of the Summer Term Funding Claim. Children must have turned the appropriate age for funding by Monday 31<sup>st</sup> March:

Children who turn 9 months, two years or three years between:	Funding can commence from:
1 <sup>st</sup> April and 31 <sup>st</sup> August	Autumn Funding Term – 1 <sup>st</sup> September
1 <sup>st</sup> September and 31 <sup>st</sup> December	Spring Funding Term – 1 <sup>st</sup> January
1st January and 31st March	Summer Funding Term – 1 <sup>st</sup> April

In addition to confirming the date of birth, please note that Eligibility Codes:

- 1. Must be applied for by Monday 31st March.
- 2. Must have a start date of Monday 31st March or before.
- 3. Must have an end date of Tuesday 1st April or later.

Any codes that are applied for between 1<sup>st</sup> April and Easter will not be valid during the Summer Term and will need to be renewed before the Autumn Term.

For term-time only settings, this means that children are eligible to access funding before the Easter break, as part of the Summer Term funding claim. If you choose not to offer places to new children until after Easter, your Summer Term claim for these children must have the number of weeks amended to reflect the reduced access. When submitting your Summer Term Estimate Claim, we would recommend using the attached Estimate Funding Calculator to ensure your Estimate claim is accurate and reflects the appropriate number of weeks for each child.

The Online Provider Portal will open on Monday 3<sup>rd</sup> March for Summer Term Estimate Claims.

#### Early Years Network for ECTs

Vicky Dunn, the new Learning and Teacher Adviser for Early Years would like to set up an Early Years Network for ECTs in Nursery and Reception. Later in the year, there may be an opportunity to include ECTs in year 1, to support with moderation and transition.

The aim of the network is to provide opportunities for Early Years ECTs to:

- Meet other Early Years ECTs in Worcestershire
- Share good practice
- Moderate outcomes
- Discuss successes and challenges
- Identify areas for further development or training
- Discuss transition both into and out of EYFS

Depending on interest, the EY ECT network would meet half termly. A meeting place will be decided, based on the location of attendees.

#### Reminder: Integrated 2 Year Check

The 2-year check should be completed by the Health Visitor (HV) or Community Nursery Nurse before 30 months. If child has not received their check, either ask parent to chase or Early Year's Setting (EYS) to contact HV team through the Children's Secure Portal (CSP).

**Step 1:** Early Years setting completes the progress check

**Step 2:** If you have no concerns: Early Years settings share the outcome of the check with parents.

Step 3: If you have concerns such as:

- Poor attendance
- Poor Diet
- Development
- Behaviour
- Poor Oral Hygiene
- Concerns about Home Environment

Early Years settings share the outcome of the check and their concerns with parents. **If the parents' consent**, you should refer to the Health Visiting team as appropriate: Send a copy of the child's completed progress review via the CSP to the relevant District (2yo integrated checks – relevant district).

**Please note**: if you have identified speech and language issues, please refer to Speech and Language Therapy services in liaison with parent/carers. There is no requirement to flag these children to the health visitor as you have already made the referral.

**Please note**: if health services are already involved with the child and are supporting with their development (i.e., known to paediatrician / child development centre / physio etc) you are not required to send information to the health visitor. Please only send information to the health visitor on children whose needs are newly identified for requiring health interventions.

**Step 4:** NHS Admin to inform named Health Visitor.

**Step 5:** Named Health Visitor to add information to the clinical note and liaise with Early Years Setting if necessary.

#### Wychavon Social Mobility Grant

Wychavon District Council have set aside £30,000 for a new Social Mobility Grant scheme to provide support and improve outcomes for eligible children and/or their families. Schools and voluntary organisations are invited to apply for small grants to help close the gap between the most disadvantaged children and young people and their peers.

Individual grant awards will normally be between £250 and £1500. Grants can be for small capital projects or revenue schemes and must be made via an online application (see below). Applicants will be expected to demonstrate the impact of the grant award as part of this process.

Successful applicants must ensure that, whilst the grant money is targeted primarily at eligible children, their projects do not stigmatise or isolate individuals or groups of children or young people.

## **Ofsted Inspection Consultation**

Following feedback from the Big Listen, Ofsted are now consulting on the way it inspects education settings, including Early Years providers and schools. The consultation includes the way in which Ofsted reports on completed inspections, as well as the way it which the inspection itself is carried out.

## National Literacy Trust – Supporting Reading in the Early Years

#### Why early experience of books and stories is important

Early experiences of reading will have significant influence on children's views and feelings about reading as they get older. It is crucial for children to develop a love of early reading to enable them to learn the necessary skills to become successful readers themselves.

<u>National Literacy Trust research</u> has shown that reading for pleasure can help children access wider benefits for learning and wellbeing as they grow. The foundations for children enjoying reading and actively choosing to read are established from their earliest experiences.

#### Free Playwork Training (Learn Through Play (10GLH))

This 5 week course is based on the 8 principles of playwork, and would benefit current childcare staff in schools, private, voluntary and independent settings working with children within Early Years through to Key Stage 2. During this course you will have the opportunity to:

- Explore what is unique about playwork.
- Understand how to facilitate positive development through play.
- Ensure that high quality play opportunities are given to children.
- Establish the professional and ethical frameworks for playwork including risk assessments and safeguarding.
- Understand how to adapt play to ensure inclusivity.
- Become an advocate for children's self-directed play.

#### This course is free to attend.

## Early Years Bulletin: Safeguarding

#### Early Years Designated Safeguarding Lead Training

Over the past few months, the Training Team have noticed delegates attending session 1 of the Early Years DSL training, and then not session 2 (or vice-versa) which then means the training is not complete.

To those delegates that are pro-active and inform the training team, thank you, this ensures that alternative sessions can be provided with necessary updates undertaken within CPD to ensure the delegate receives the joining instructions to be able to complete the training.

For those delegates who do not make any contact to the training team about missing sessions please be aware that:

- Your setting could incur additional charges as the replacement session has not been organised promptly
- By only attending one of the sessions, 3 hours of the total 6-hour training, you have not completed your full Early Years DSL training
- If the lead practitioner for safeguarding (DSL) does not have a full and relevant DSL qualification you would be in breach of the safeguarding and welfare requirements of the EYFS.

The training team ask that if you do miss one of your sessions in relation to the Early Years DSL course, please advise the team as soon as possible. This will ensure alternative sessions and options can be discussed: we have dates arranged from April 2025 to March 2026. ### Domestic Abuse in Worcestershire

Worcestershire has partnered with domestic abuse charity Safe Lives in operationalising a Public Health Approach to improve the response to Domestic Abuse.

Worcestershire County Council are working with <u>Safe Lives</u>, the UK-wide charity dedicated to ending domestic abuse, for everyone and for good. Safe Lives work with organisations across the UK to transform the response to domestic abuse.

Safe Lives want what you would want for your best friend, they listen to survivors, putting their voices at the heart of their thinking.

They look at the whole picture for every individual in the family, to get them the right help at the right time, so families everywhere can be safe and well. And challenge perpetrators to change, asking 'why doesn't he stop?' rather than 'why doesn't she leave?' This applies whatever the gender of the victim or perpetrator and whatever the nature of their relationship.

Last year alone, they trained more than 11,500 professionals and first responders, reached almost 90,000 adult and 100,000 child survivors through programmes designed and delivered with partners. And in the last six years, more than 5,000 perpetrators have been challenged and supported to change through interventions developed by their flagship <u>Drive Partnership</u>, and the programme continues to expand year on year.

Part of improving how things work means that we need to speak to those who have had these experiences to listen to what they have to say. As part of this, we are now launching our public surveys for victims and survivors and children and young people.

We are asking all agencies to support with sharing the survey as much as possible to enable us to have the best and most meaningful response by **24/02/2025**.


## Discovering the value of wordless books

We all recognise the joy and importance of reading and sharing high-quality stories with young children. But have you ever considered the benefits of wordless books?

- **Develop comprehension skills**: Without text, children rely on the details in the illustrations to help them understand the story. This can enhance their ability to infer meaning and predict what they think might happen.
- Increase confidence and independence: Children can "read" wordless books on their own, boosting their confidence and fostering a love for reading
- **Enhance verbal skills and discussion**: Discussing the story based on pictures encourages children to articulate their thoughts and engage in storytelling
- **Support Vocabulary Acquisition**: When sharing a wordless book with an adult, the adult can introduce ambitious language and new concepts. Children are then able to describe the images and re-tell the story using this new vocabulary.
- **Encourage Visual Literacy**: Children learn to interpret visual information, which is a crucial skill in our image-rich world
- **Promote Creativity and Imagination**: Without words, children can create their own narratives, fostering creativity

Here are five wordless books which might appeal to the children in your setting or class.


**Dog on a Digger** by Kate Prendergast: A heartwarming story about the bond between a dog and his owner, conveyed through beautiful pencil drawings



**The Boy & the Book** by David Michael Slater: In this wordless story, a library book tries desperately to evade the destructive clutches of a

little boy. What drives the Boy, however, is enthusiasm and love—not malice—and the Book eventually responds in kind, accepting his rough but worthy fate.





**Professional Crocodile** by Giovanna Zoboli and Mariachara Di Giorgio: A delightful story exploring what a crocodile does for a living.

Wave by Suzy Lee: This beautiful wordless book tells the story of a little girl's day at the beach.
