Map and plan of the area

Map of St Georges Road and Grange Road, Redditch and the prohibition of waiting zone implemented by the above order.

Description of the map

The map shows the prohibition of waiting zone on St Georges Road and Grange Road, Redditch:

St Georges Road (Southeast side): from its junction with Grange Road for a distance of 4 metres in a north easterly direction and 8.6 metres in a south westerly direction.

Grange Road (Northeast side): from its junction with St Georges Road for a distance of 5 metres in a south easterly direction.

(Southwest side): from its junction with St Georges Road for a distance of 11 metres in a south easterly direction.
