Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (CITY OF WORCESTER) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2011 (VARIATION) ORDER 2025 [VARIOUS WAITING RESTRICTIONS (PROPOSALS AND REVOCATIONS) ON BARBOURNE TERRACE, WORCESTER]

Description of the map

The map shows the Various Waiting Restrictions on Barbourne Terrace, Worcester:
Barbourne Terrace (South East side): From its junction with A38 Tything/Barbourne Road for a distance of 103 metres in a south westerly direction.

Revocation of Restriction of Waiting Mon-Sat 8am-6.30pm

From its junction with A38 Tything/Barbourne Road for a distance of 98 metres in a south westerly direction.

Revocation of Limited Waiting 45 mins No Return Within 2 Hours Mon-Sat 8am-6.30pm Except Permit Holders

From a point 98 metres south west of its junction with A38 Tything/Barbourne Road for a distance of 5 metres in a south westerly direction.
