Description of the map

The map shows the prohibition of waiting zone on Ellison Avenue and Laxton Avenue, **Worcester:**

Ellison Avenue (North side): from its junction with Laxton Avenue for a distance of 8 metres in an easterly direction and 9 metres in a westerly direction.

Laxton Avenue (Both sides): from its junction with Ellison Avenue for a distance of 9 metres in a northerly direction
