# Map and plan of the area

Map of Lark Hill Road and Woodside Road, Worcester and the prohibition of waiting zone implemented by the above order.

## Description of the map

The map shows the prohibition of waiting zone on Lark Hill Road and Woodside Road, Worcester

**Lark Hill Road (Northwest side)** from its junction with Woodside Road for a distance of 8 metres in a north easterly direction.

**Woodside Road (Northeast side)** from its junction with Lark Hill Road for a distance of 7 metres in a north westerly direction.

**Northwest side:** from a point 5 metres northwest of its junction with Lark Hill Road for a distance of 2 metres in a north westerly direction.
