Description of the map

The map shows the prohibition of waiting zone on Lark Hill Road and Woodside Road, Worcester

Lark Hill Road (Northwest side) from its junction with Woodside Road for a distance of 8 metres in a north easterly direction.

Woodside Road (Northeast side) from its junction with Lark Hill Road for a distance of 7 metres in a north westerly direction.

Northwest side: from a point 5 metres northwest of its junction with Lark Hill Road for a distance of 2 metres in a north westerly direction.
