

Map of Calder Road and Mersey Road, Worcester and the prohibition of waiting zone implemented by the above order.

Description of the map

The map shows the prohibition of waiting zone on Calder Road and Mersey Road, Worcester

Calder Road (South side) from its junction with Mersey Road for a distance of 13 metres in a westerly direction and 12 metres in an easterly direction.

Mersey Road (Both sides) from its junction with Calder Road for a distance of 8 metres in a southerly direction.
