Map of Lambert Road and Bozward Street, Worcester and the prohibition of waiting and restriction of waiting zones implemented by the above order.

#### **Description of the map**

The map shows the prohibition of waiting and restriction of waiting zones on Lambert Road and Bozward Street, **Worcester: -**

#### Prohibition of Waiting at any time

**Lambert Road (North side):** from its junction with Bozward Street for a distance of 5 metres in both an easterly and westerly direction. **Bozward Street (Both sides):** from its junction with Lambert Road for a distance of 5 metres in a northerly direction.

#### Restriction of Waiting Mon-Fri 8.30am-5pm

**Lambert Road (North side):** from a point 12 metres west of its junction with Comer Road for a distance of 15 metres in a westerly direction.

#### Revocation of Restriction of Waiting Mon-Fri 8.30am-5pm

**Lambert Road (North side):** from its junction with Bozward Street for a distance of 5 metres in an easterly direction.

## Revocation of Limited Waiting 45 Mins No Return Within 2 Hours Mon-Fri 8.30am-5pm

**Lambert Road (North side):** from a point 12 metres west of its junction with Comer Road for a distance of 15 metres in a westerly direction
