## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (CITY OF WORCESTER) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2011 (VARIATION) ORDER 2025 VARIOUS WAITING RESTRICTIONS (PROPOSALS AND REVOCATION) ON LAUGHERNE ROAD AND COMER ROAD, WORCESTER**

The Order shall come into operation on 20 February 2025 and may be cited as Worcestershire County Council (City of Worcester) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2011 (Variation) Order 2025 [Various Waiting Restrictions (Proposals and Revocation) on Laugherne Road and Comer Road Worcester]

## Map and plan of the area

Map of Laugherne Road and Comer Road, Worcester and the various waiting restriction zones implemented by the above order.

### Description of the map

The map shows the various waiting restriction zones on Laugherne Road and Comer Road, Worcester:

**Laugherne Road (west side)** from its junction with Rowley Hill Street for a distance of 6 metres in a northerly direction.

**Laugherne Road (west side)** from a point 6 metres south of its junction with Rowley Hill Street for a distance of 6 metres in a southerly direction.

**Restriction of Waiting MON-FRI 8.30am-5pm**

**Laugherne Road (west side)** from a point 10 metres north of its junction with Buck Street to a point 10 metres south of its junction with Windsor Avenue.

**Laugherne Road (east side)** from a point 13 metres north of the centre line of its junction with Windsor Avenue for a distance of 7 metres in a northerly direction.

**Revocation of Restriction of Waiting Mon-Fri 8.30am-5pm**

**Comer Road (east side):** from a point 30 metres north of its junction with Nelson Road for a distance of 21 metres in a northerly direction.
