# Map and plan of the area

Map of Laugherne Road and Comer Road, Worcester and the various waiting restriction zones implemented by the above order.

## **Description of the map**

The map shows the various waiting restriction zones on Laugherne Road and Comer Road, **Worcester:** 

**Laugherne Road (west side)** from its junction with Rowley Hill Street for a distance of 6 metres in a northerly direction.

**Laugherne Road (west side)** from a point 6 metres south of its junction with Rowley Hill Street for a distance of 6 metres in a southerly direction.

Restriction of Waiting MON-FRI 8.30am-5pm

**Laugherne Road (west side)** from a point 10 metres north of its junction with Buck Street to a point 10 metres south of its junction with Windsor Avenue.

Laugherne Road (east side) from a point 13 metres north of the centre line of its junction with Windsor Avenue for a distance of 7 metres in a northerly direction.

Revocation of Restriction of Waiting Mon-Fri 8.30am-5pm

**Comer Road (east side):** from a point 30 metres north of its junction with Nelson Road for a distance of 21 metres in a northerly direction.
