Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

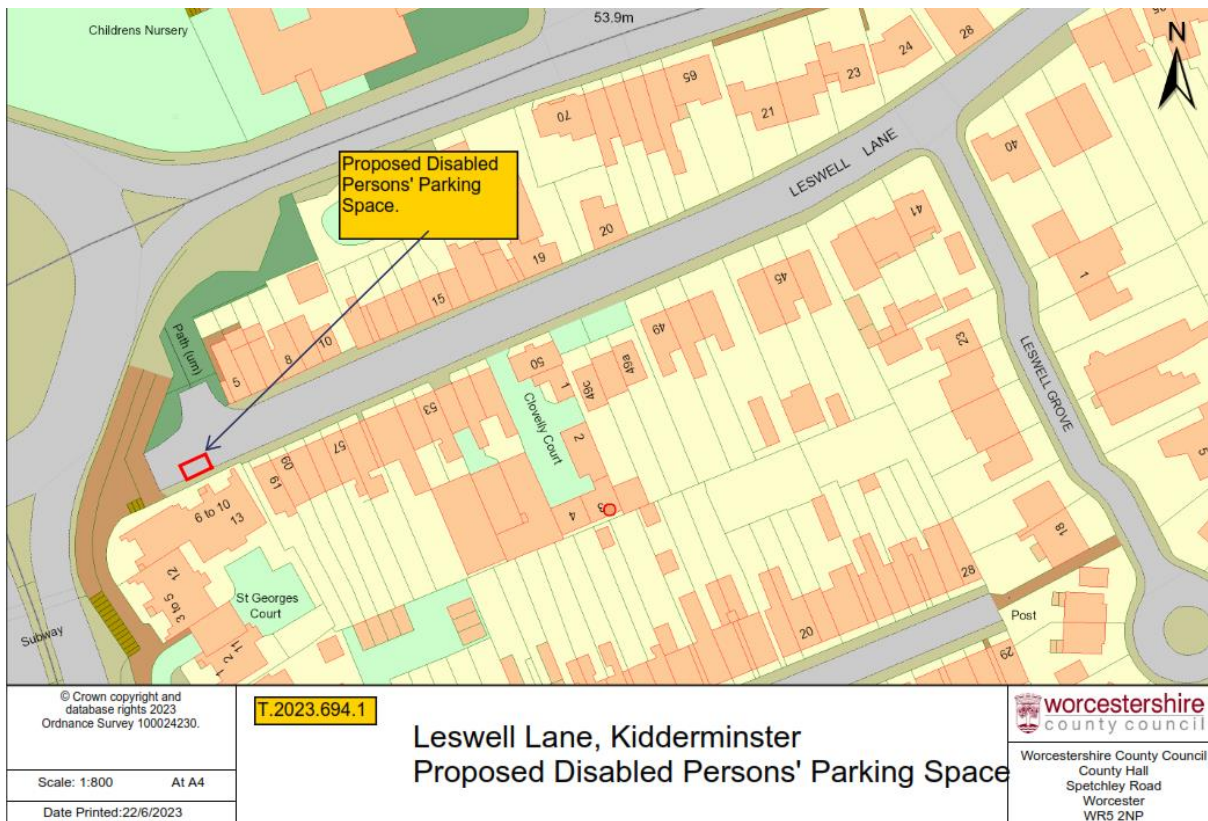


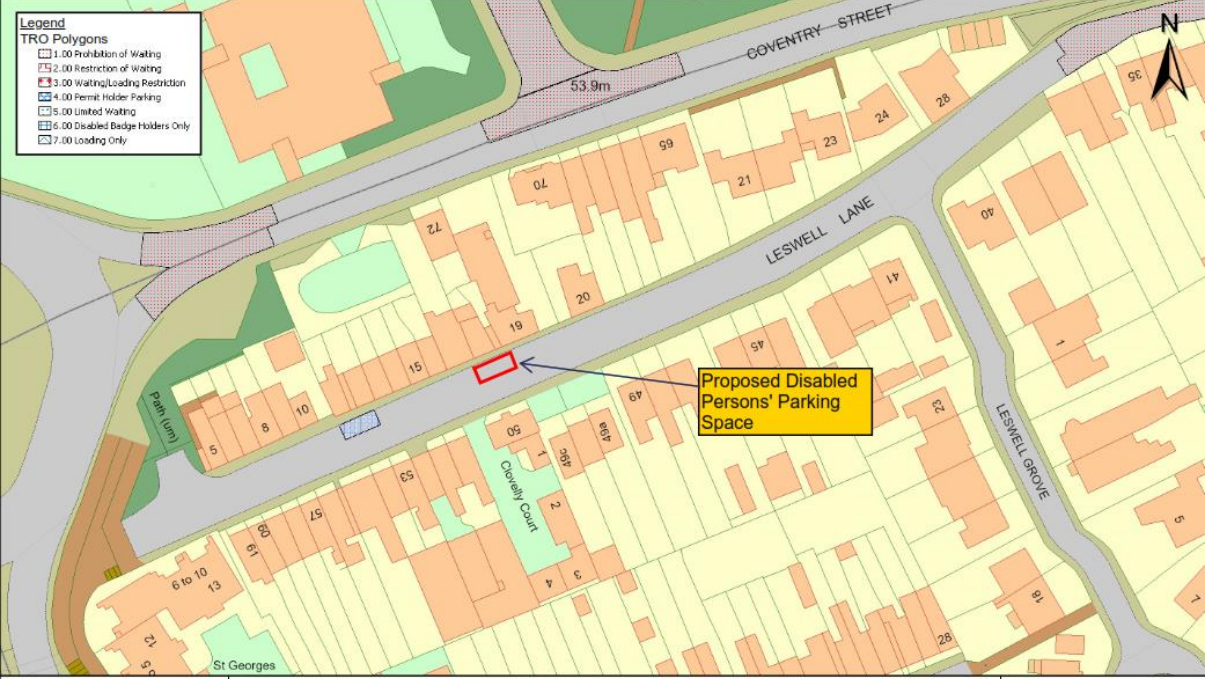
Map and plan of the area

Description of the map

The map shows the disabled persons' parking space on Leswell Lane, **Kidderminster**:
Leswell Lane – Southeast side: from a point of 142 metres southwest of its junction with Leswell Grove for a distance of 6.6 metres in south westerly direction.
Leswell Lane – Northwest side: from a point of 74 metres southwest from the centre of the junction with Leswell Grove for a distance of 6.6 metres in south westerly direction.
