#### **Description of the map**

The map shows the prohibition of waiting zone on Lickhill Road and Private Access Road, **Stourport:** 

**Lickhill Road (Northeast side)** from the centre point of its junction with the private access road for a distance of 15.5 metres in a north westerly direction.

(Southwest side): from its junction with the private access road for a distance of 14.1 metres in a north westerly direction.

**Private access road (Both sides)** from its junction with Lickhill Road for a distance of 12.8 metres in a southerly direction.
