Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT – STOURPORT area) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON LICKHILL ROAD AND PRIVATE ACCESS ROAD, STOURPORT]

Worcestershire County Council have made this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.



Map of Lickhill Road and Private Access Road, Stourport and the prohibition of waiting zone implemented by the above order

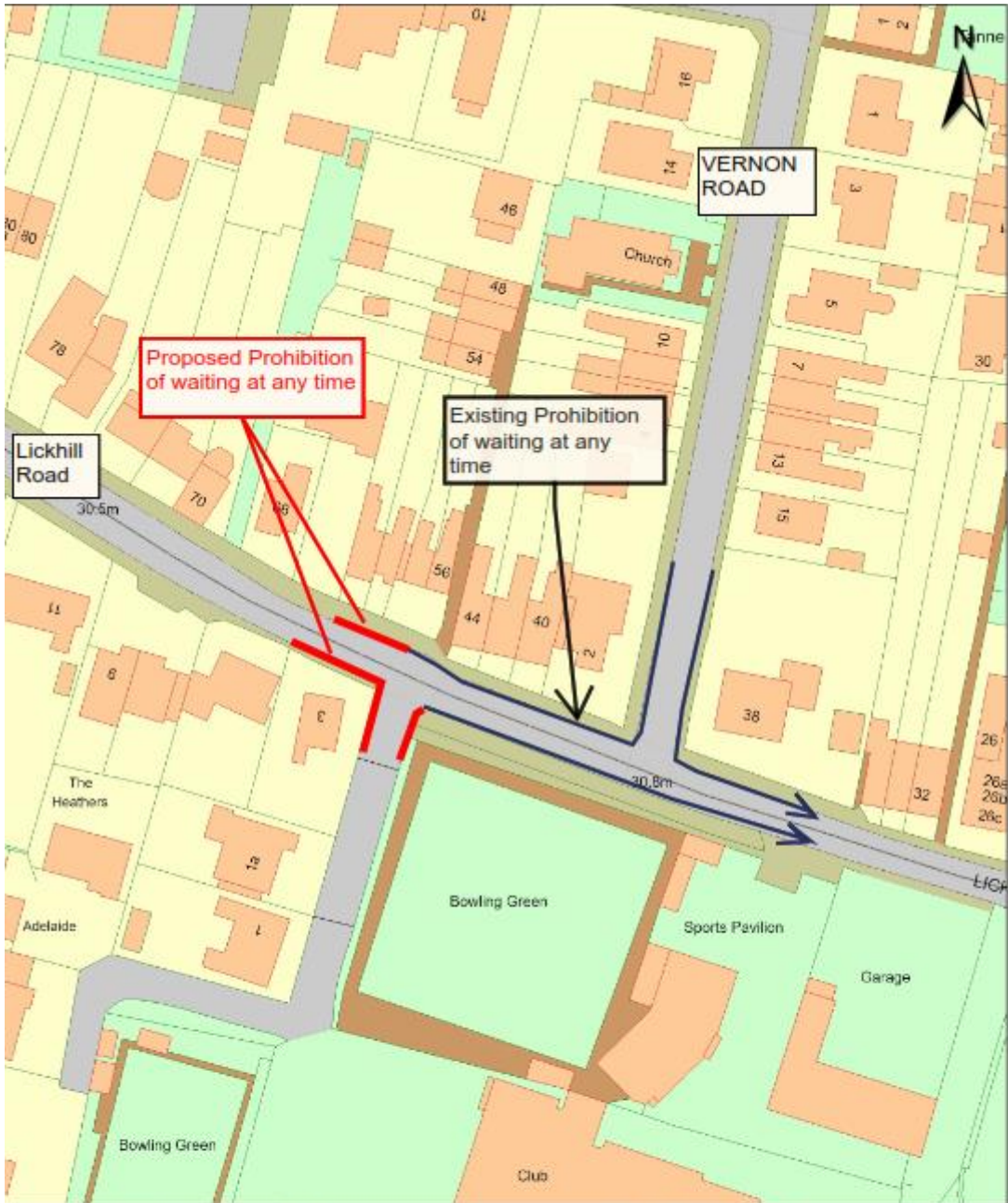
Description of the map

The map shows the prohibition of waiting zone on Lickhill Road and Private Access Road, **Stourport:**

Lickhill Road (Northeast side) from the centre point of its junction with the private access road for a distance of 15.5 metres in a north westerly direction.

(Southwest side): from its junction with the private access road for a distance of 14.1 metres in a north westerly direction.

Private access road (Both sides) from its junction with Lickhill Road for a distance of 12.8 metres in a southerly direction.
