Map of Westwood Road, Farmers Way & Paddock Way, Droitwich and the prohibition of waiting zone implemented by the above order.

Description of the map

The map shows the prohibition of waiting zone on Westwood Road, Farmers Way & Paddock Way, **Droitwich**:

Westwood Road (East side): From a point 10 metres south of its junction with Farmers Way for 230 metres in a northerly direction.

(West side): From a point 10 metres south of its junction with Farmers Way for 235 metres in a northerly direction.

Farmers Way (Both sides): From its junction with Westwood Road for 10 metres in an easterly direction.

Paddock Way (Both sides): From its junction with Westwood Road for 10 metres in a westerly direction.
