# Map and plan of the area

Map of Williamson Road, Worcester and the Prohibition of Waiting zone implemented by the above order.

### **Description of the map**

The map shows the prohibition of waiting zone on Williamson Road, Worcester:

**Williamson Road (West side):** from a point 63 metres south of its junction with Newtown Road for a distance of 17 metres in a south-westerly direction.

**Williamson Road (West side):** from a point 131 metres south of its junction with Newtown Road for a distance of 76 metres in a southerly direction.

**Williamson Road (East side):** from a point 18 metres south of its junction with Newtown Road for a distance of 184 metres in a southerly direction.

**Williamson Road (East side):** from a point 245 metres south of its junction with Newtown Road for a distance of 50 metres in a southerly direction.

**Williamson Road (East side):** from a point 373 metres south of its junction with Newtown Road for a distance of 50 metres in a southerly direction.

Restriction of Waiting Monday to Friday 8 am-5.30 pm

**Williamson Road (West side):** from a point 80 metres south of its junction with Newtown Road for a distance of 51 metres in a south-westerly direction.

**Williamson Road (West side):** from a point 334 metres south of its junction with Newtown Road for a distance of 78 metres in a southerly direction.
