### Description of the map

The map shows the No Waiting zones on Batchley Road, Hewell Road, **Redditch:-**

**Hewell Road (South Side) - No Waiting at Any Time**

From a point 30m east of its junction with Batchley Road for a distance of 16m in an easterly direction.

**(North Side) - No Waiting at Any Time**

From a point 30m east of its junction with Batchley Road for a distance of 112m in an easterly direction.

**Batchley Road- (North Side) - No Waiting at Any Time**

From a point 16m north of its junction with Ash Tree Road for a distance of 42m in a northerly direction.
