# **Core Group Practice Briefing for Professionals**

The core group is the Interagency Forum for achieving the outcomes of a child protection plan. It is comprised of the professionals responsible for delivering particular aspects of the plan, and is attended by parents and children, where appropriate. The membership of the core group is agreed at an initial child protection conference, although this may be amended to include all relevant individuals jointly responsible for delivering the child protection plan.

# Worcestershire Safeguarding Children Partnership Newsletter: Learning from Rapid Reviews

The statutory guidance 'Working Together to Safeguard Children' (December 2023) requires that when a serious incident (normally one where abuse or neglect of a child is known or suspected and the child has died or been seriously harmed) becomes known to safeguarding partners, they must consider whether the case meets the criteria and guidance for a local review. If safeguarding partners determine that the criteria is met to undertake a local child safeguarding practice review, then a serious incident notification and rapid review must take place.

Worcestershire Safeguarding Children Partnership do complete rapid reviews of cases which do not then progress to full child safeguarding practice reviews (CSPR's). Learning is often identified from these rapid reviews however, and it is as important that such learning is shared from rapid reviews as from our published CSPR's.

The <u>WSCP Newsletter: Learning from Rapid Reviews (opens in new window)</u> focuses on the learning from some of our recent rapid reviews, and we (WSCP) would ask that you take the time to read it and share it with colleagues where appropriate.

#### Ofsted safeguarding audit

If you have purchased our safeguarding SLA and are due Ofsted within in the next 2 terms, you are eligible to request a self-assessment, safeguarding audit/ single central record review from a member of the Safeguarding team — Denise Hannibal or Hayley Doyle.

- 1 day research of your schools safeguarding policy and procedures including your website
- A review of your annual Section 175/157 audit, including any actions plans
- A thorough assessment of your Single central record and safer recruitment process
- We will meet with your safeguarding team including the safeguarding Governor
- We will gather the voice of the child
- We will talk to staff and their understanding and knowledge and how to keep children safe
- A comprehensive report including development plan

#### Single central record health-check

Schools and colleges must maintain a single central record of pre-appointment checks. Keeping Children Safe in Education 2024 Your single central record is a key part of evidence that inspectors will look at when inspecting your school safeguarding Working with the person who is responsible for the maintenance of your Single Central Record (SCR), to help them ensure that it is usable, efficient and compliant. We would also welcome the involvement of your safeguarding governor as the health check can assist them in continued monitoring of the SCR The package includes:

A review of the SCR, comparison with the requirements of 'Keeping Children Safe in Education (September 2024) and checking for gaps

- Health check report
- Includes 2 places on the WCF SCR training.
- Telephone and email support
- A follow up visit to check on progress and offer further advice.

#### The Young Person's Prevention Project

Are unhealthy relationships and misogyny a concern in your school or community? West Mercia Women's Aid, The RightPath and Everyone's Invited have partnered to deliver "The Young Person's Prevention Project", an education and community programme running across West Mercia to tackle misogyny and stereotypes.

#### Who is the programme for?

The programme is available to all young people across West Mercia. The RightPath and Everyone's Invited will be running awareness raising sessions and workshops in Schools, while West Mercia Women's Aid will offer community-based support, including but not limited to; youth groups, those not in employment, education or training (NEET), those who are home-schooled, looked after children and unaccompanied asylum seeking children. # UK Feminista's research highlighted in Parliament

UK Feminista and NEU's research has recently been highlighted in Parliament by Katrina Murray MP. 'It's Just Everywhere (opens in new window)', reveals that over a third of girls report having been



sexually harassed at school.

UK Feminista's <u>online resource hub (opens in new window)</u> contains guidance and practical resources to support schools to tackle sexism and sexual harassment. This includes classroom activities, tools on taking a whole school approach to tackling sexism, template student and staff surveys, tips for teachers and classroom posters.

## UK Feminista: Free online teacher training course

Our (UK Feminista) <u>online teacher training course (opens in new window)</u> equips teachers and trainee teachers with the tools, knowledge and confidence to tackle sexism and sexual harassment.

The course consists of three modules and takes approximately 90 minutes to complete. It includes interactive exercises, case studies, video content and classroom resources.

The course is free to access and can be delivered internally by schools and Initial Teacher Training providers. Participants can complete the course at a time and location of their choosing and everyone who completes the course receives a certificate.

# UK Feminista: Live training for your school / college

UK Feminista supports schools to take a whole school approach to tackling sexism – including sexual harassment, sexist language and gender stereotyping. We offer in-house Continuing Professional Development training to equip teachers with the skills, knowledge and confidence to tackle sexism. Our training is also available for Initial Teacher Training providers.

UK Feminista's in-house teacher training sessions can be delivered in-person (on the school or college premises) or online (via Microsoft Teams). The training can be offered as a 1.5 hour, 2.5 hour (half day) or 5 hour (full day) session.

Participants will have the opportunity to explore practical activities that can be used to promote equality in the classroom, as well as strategies and tools for implementing a whole school approach to tackling sexism.

# Healthy Relationships – staff training and sessions/support for young people

West Mercia Women's Aid (opens in new window), The Rightpath (opens in new window) and Everyone's Invited (opens in new window) have teamed up to provide a range of healthy relationship sessions for Schools across West Mercia.



The sessions are free and aimed at years 7, 8 & 9.

Schools can choose from a one-off awareness session to a whole year group or a more intensive set of 3 sessions with 6-8 students. WCC Public Health would encourage you to take up both options and get the most from this great opportunity.

The sessions will cover sexual well-being, healthy relationships, gender stereotypes, misogyny, what harmful behaviours may look like and objectification. The sessions will be interactive and encourage young people to explore these topics in a non-judgemental way enabling them to feel seen and heard.

Staff and DSL's will also be offered a session to help them address these topics in schools which will lead to long term change.

## #CUT IT OUT: Raising Awareness of and Tackling Domestic Abuse

Both South Worcestershire Community Safety Partnership and North Worcestershire Community Safety Partnership are working with Martin Lakeman, (Domestic Abuse and Safeguarding Consultant) to deliver free sessions in raising awareness around the devastating impact of domestic abuse through the #Cut It Out initiative.

These free sessions are open to any professional working in a school and are free to attend.

1 in 4 women and 1 in 6 men will experience domestic abuse at some point in their life. #Cut It Out recognises that certain professionals are in a position of privilege with their clients, not only working physically close to them but also very often, they are someone trusted to talk to or confide in. This initiative aims to help professionals recognise the signs of domestic abuse, whilst raising awareness of where they can signpost family members, friends, friends of friends, business colleagues, clients to get help and importantly give professionals the confidence to start that difficult conversation.
