Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT – KIDDERMINSTER AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON HABBERLEY ROAD, ST JOHNS AVENUE & BRIARS GARDENS, KIDDERMINSTER]

Worcestershire County Council propose to make an Order for facilitating the safe passage on the roads or any other road of any class of traffic and for avoiding danger to persons or other traffic using the roads or any other road or for preventing the likelihood of any such danger arising.

It is considered that the Order will contribute to the securing of the expeditious, safe and convenient movement of all traffic (including pedestrians) and will have no adverse effect on other considerations contained in s.122 Road Traffic Regulation Act 1984.

Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2), and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (Wyre Forest District – Kidderminster area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2007 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the sides of roads identified in the plan attached to this Order a prohibition of waiting in accordance with the provisions of the Consolidation Order).
2. The Order shall come into operation on XXXXX 2025 and may be cited as Worcestershire County Council (Wyre Forest District – Kidderminster area) (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2007 (Variation) Order 2025 [Prohibition of Waiting on Habberley Road, St Johns Avenue & Briars Gardens, Kidderminster]

Map of Habberley Road, St Johns Avenue & Briars Gardens, Kidderminster and the proposed **prohibition of waiting zone** to be implemented by the above order

Description of the map

The map shows the proposed **prohibition of waiting zone** on Habberley Road, St Johns Avenue & Briars Gardens, **Kidderminster**:

Habberley Road (south side): from its junction with St Johns Avenue for a distance 11 metres in a north westerly direction and 12 metres in an easterly direction.

Habberley Road (North side): from its junction with Briars Gardens (private road) for a distance 9 metres in a north westerly direction and 7 metres in an easterly direction.

Briars Gardens (private road) (both side): from its junction with Habberley Road for a distance of 7 metres in a southerly direction.

St Johns Avenue (west side): from its junction with Habberley Road for a distance 17 metres in a southerly direction.

St Johns Avenue (east side): from its junction with Habberley Road for a distance 14 metres in a southerly direction.
