Map of Bromwich Road and Whites Road, Worcester and the Prohibition of Waiting zone implemented by the above order.

### **Description of the map**

The map shows the Prohibition of Waiting zone on Bromwich Road and Whites Road, **Worcester:** 

**Bromwich Road (West side):** from its junction with Whites Road for a distance of 33 metres in a northerly direction and 27 metres in a south westerly direction; and from a point 15 metres southwest of its junction with Bromwich Road Service Road (north junction) for a distance of 14 metres in a south westerly direction.

Whites Road (North side): from its junction with Bromwich Road for a distance of 32 metres in a westerly direction;

(South side): from its junction with Bromwich Road for a distance of 25 metres in a westerly direction.
