Map of Merse Road, Redditch and the **Prohibition of Waiting zone** implemented by the above order.

Description of the map

The map shows the **Prohibition of Waiting zone** on Merse Road, **Redditch:**

Burnt Meadow Road (North side) from its junction with Merse Road for a distance of 10 metres in a north easterly direction (**South side**) from its junction with Merse Road for a distance of 10 metres in a north easterly direction.

Merse Road (Northeastern side) from its junction with Burnt Meadow Road for a distance of 10m in a northwestern direction (Northeastern Side) from its junction with Burnt Meadow Road for a distance of 10m in a Southeastern direction (Northeastern Side) from a point 18 metres from its junction with Burnt Meadow Road for a distance of 10m in a Southeastern direction (Northeastern Side) from a point 33 metres from its junction with Burnt Meadow Road for a distance of 10m in a Southeastern direction (Northeastern Side) from a point 90 metres from its junction with Burnt Meadow Road for a distance of 10m in a Southeastern direction (Northeastern Side) from a point 108 metres from its junction with Burnt Meadow Road for a distance of 10m in a Southeastern direction (Northeastern Side) from a point 140 metres from its junction with Burnt Meadow Road for a distance of 10m in a Southeastern direction (Southwestern Side) from its junction with Eagle Road for a distance of 10 metres in a north western direction (Southwestern Side) from its junction with Eagle Road for a distance of 10 metres in a South Western direction

Eagle Road (Northern side) From its junction with Merse road for a distance of 10 metres in a westerly direction

(Southern Side) from its junction with Merse Road for a distance of 10 metres in a westerly direction.
