Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (BOROUGH OF REDDITCH) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2009 (VARIATION) ORDER 2025 [PROHIBITION OF WAITING ON VICARAGE CRESCENT & BROMSGROVE ROAD

Worcestershire County Council have made this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

Map of Vicarage Crescent & Bromsgrove Road, Redditch and the **prohibition of waiting zone** implemented by the above order.

Description of the map

The map shows the **prohibition of waiting zone** on Vicarage Crescent & Bromsgrove Road, Redditch:

Vicarage Crescent (Eastern Side): from its junction with Bromsgrove Road for a distance of 10 metres in a southerly direction.

(Western side): from its junction with Bromsgrove Road for a distance of 10 metres in a southerly direction.

Bromsgrove Road (Southeast side): from its junction with Vicarage Crescent for a distance of 10 metres in an easterly direction.

(Southwest side): from its junction with Vicarage Crescent for a distance of 10 metres in a westerly direction.
