# Safeguarding SLA for 25/26

We are pleased to confirm that the Safeguarding SLA for 25/26 is now available to purchase via eStore. To download the latest Education Services Directory and see exactly what our SLA covers, visit our Support Services website and click on the Education Services Directory 25/26 button

For 25/26 year we have some incredible discounts available:

- if you have continuously bought into the Safeguarding SLA for the last 4 years (since September 2021) then get a 10% discount: OR
- if you bought into the SLA for 3 consecutive years (aka didn't buy 24/25) then if you buy back in 2025 -2026 you get 5% discount: OR

# Changes to Multi-Agency Child Safeguarding Procedures - Monday 3rd March 2025

From Steve Eccleston, Worcestershire Safeguarding Children Partnership Independent Scutineer.

The West Midlands Regional Safeguarding Procedures website will change on 3<sup>rd</sup> March 2025 when the hosting of the procedures moves from our current supplier Phew to Tri.x. We have worked closely with Tri.x to ensure that the new website includes information from our current procedures that are specific to the West Midlands and that all procedures are compliant with Working Together 2023.

The changes will affect practitioners working in the following local authority areas: Birmingham, Coventry, Dudley, Herefordshire, Sandwell, Shropshire, Solihull, Stoke on Trent, Telford and Wrekin, Walsall, Warwickshire, Wolverhampton and Worcestershire. If you are a practitioner working in one of these areas, you will need to access procedures via a new link which is <a href="https://westmids-worcestershire.trixonline.co.uk/">https://westmids-worcestershire.trixonline.co.uk/</a>. Please note, this link is not yet 'live' but will need to be used on and after Monday 3<sup>rd</sup> March 2025. This link takes the user directly to the Worcestershire section of the new website, but there will be the option to click back to the main West Midlands landing page from each area portal, which will be useful for agencies that cover more than one partnership area.

It should be noted that existing shortcuts to the outgoing Phew website which have been set up on desktops or mobile phones will need to be changed, albeit a redirection service will be in place for a short period after the change. In addition, arrangements will need to be made to change links currently hosted on staff intranets and other websites.

# **Private Fostering**

Worcestershire Fostering are keen to share the following document with professionals across the county, <u>Private Fostering: a guide to professionals</u> along with the following notes:

A privately fostered child is a child under 16 (or 18 if disabled) who is being cared for, for 28 days or more, by an adult who is NOT their parent, stepparent, grandparent, aunt, uncle, sister or brother.



It's usually a cousin or great aunt, a friend of the family, or someone who has agreed to take care of the child by private arrangement without involving the council.

The parent is still legally responsible for their child. Children Services have a legal duty to ensure children in this situation are safe and well.

#### **Examples of private foster care arrangements:**

- There are a number of cases in Worcestershire where a birth parent has left the household through relationship break down or are in prison and the child is left in the care of the birth parent's partner. The child will often view this person as a step parent, however if the parent and step parent are not married or in a civil partnership it will fall under Private Fostering Regulations and Children's Services need to be notified.
- Children in this country for education or health care by parents or guardians living overseas. A recent example was a child from Germany whose parents had arranged for a host family to have power of attorney. As the host family is not a close relative this is still private fostering and Children Services need to be notified.
- Teenagers living with a friend's family as a result of problems at home.
- Children on holiday exchanges that last for more than 28 days.

As a school you have a legal duty to notify Children's Social Care of Private Fostering arrangements.

If you have purchased our safeguarding SLA and are due Ofsted within in the next 2 terms, you are eligible to request a self-assessment, safeguarding audit/ single central record review from a member of the Safeguarding team — Denise Hannibal or Hayley Doyle.

#### Standalone safeguarding support packages

- 1 day on school site
- 1 day research of your schools safeguarding policy and procedures including your website
- A review of your annual Section 175/157 audit, including any actions plans
- A thorough assessment of your Single central record and safer recruitment process
- We will meet with your safeguarding team including the safeguarding Governor
- We will gather the voice of the child



- We will talk to staff and their understanding and knowledge and how to keep children safe
- A comprehensive report including development plan

#### Single central record health-check

Schools and colleges must maintain a single central record of pre-appointment checks. Keeping Children Safe in Education 2024 Your single central record is a key part of evidence that inspectors will look at when inspecting your school safeguarding Working with the person who is responsible for the maintenance of your Single Central Record (SCR), to help them ensure that it is usable, efficient and compliant. We would also welcome the involvement of your safeguarding governor as the health check can assist them in continued monitoring of the SCR The package includes:

A review of the SCR, comparison with the requirements of 'Keeping Children Safe in Education (September 2024) and checking for gaps

- Health check report
- Includes 2 places on the WCF SCR training.
- Telephone and email support
- A follow up visit to check on progress and offer further advice.
